

Recently we've faced many challenges – the pandemic, economic disruption, rising mental health pressures – and we've worked diligently to help Alberta's communities navigate these issues. Here's a look back at our work to support building strong and resilient Alberta communities.

Cost savings and budget certainty.

Recognizing the challenges we're all facing, we froze member fees in 2021.

Insurance & Risk Services

We take pride in providing access to coverages that aren't easily achieved and that are tailored to member needs.

Our goal is to continue to shield members from dramatic premium increases. We offset premiums by providing a rebate of **\$2M in 2020** and **\$4M in 2021** to shield members from market shocks.

Employee Benefits

Our program leverages the strength of our membership, allowing us to build efficient plans.

For 2021, our Employee Benefits renewal rates increased **AN AVERAGE OF JUST 5%** when other provider rates skyrocketed.





Energy

Our Energy Program provides outstanding value through aggregation, expert advice, and industry leading customer service.

Through our unique aggregation procurement, we secured electricity rates more than 10% below market forecasts in 2020. And our 2021 natural gas aggregation secured rates 5% below the future market forecasts for over 100 members.

Retirement Services

We offer a full suite of retirement products. With three different retirement plans and two types of savings programs — we have a product to fit your needs.

2021 contribution rates for retirement products remained the same as last year, allowing for budget certainty in uncertain times.

MAINTAINING MENTAL FITNESS

As demands on mental health increased, we found new ways to support municipal employees.

Our Maintaining Mental Fitness initiative, a free weekly webinar series, attracted almost 1000 people to the virtual sessions each week.

PSYCHOLOGICAL SERVICES

Our Employee Benefits program has doubled the annual maximum for psychological services, raising the available yearly claim amounts from \$750 to \$1500.

MENTAL HEALTH NAVIGATOR

Best Doctors, our partner program that offers access to expert medical opinions, expanded to include the Mental Health Navigator companion program, providing participants with access to a team of leading psychologists and psychiatrists.

Municipal infrastructure funding.



We've worked to ensure all levels of government understand the financial crisis our municipalities are facing. We will continue to advocate for municipal infrastructure funding as there cannot be a full recovery without strong municipalities.

As you navigate upcoming projects, we will continue to support you.


Our Construction Insurance puts you in control of your new projects and makes sure your interests are protected.
