Extended Producer Responsibility (EPR)

- ABmunis has advocated for an EPR packaging and paper program since 2019.
- Regulations introduced in November 2022 makes producers responsible for plastic and paper recycling collection and management.
- Starting in 2025, producers will begin taking over recycling collection and management from municipalities.


