Libraries and ICF

- MGA 708.29(1) A framework must describe the services to be provided under it that ***benefit residents in more than one of the municipalities*** that are parties to the framework.
- ICF Workbook 2018 – Municipalities to inventory all services provided by municipalities including those provided by third parties.



“Third Party”

- Town of Cardston Bylaw 1539
- Town covers 81.4% of all annual expenses
- Owns the building
- Employs the manager
- Provincial Libraries Grant 6.2%

- Initially included and negotiated
- Interpretation changed in 2020



Arbitration

- MGA provides for arbitration of ICF items in sections 708.34 - 708.36, 708.38, 708.41, 708.48
- If unable to agree by deadline, required to submit to arbitration process as set out in Division 2.
- Town and County “agreed” to arbitrate
- Notice of arbitration
- Submitted ICF



Ministerial Order

I, Ric McIver, Minister of Municipal Affairs, pursuant to Section 708.412(1) of the Municipal Government Act, make the following order:

That the Intermunicipal Collaboration Framework (ICF) as set out in the attached Appendix is hereby established for the Town of Cardston (town) and Cardston County (county) notwithstanding:

Libraries clause is excluded and redacted.

Reference to adoption by bylaw and signature blocks for the Mayor and Chief Administrative Officer of the Town of Cardston, and Reeve and Chief Administrative Officer of Cardston County are excluded and redacted.



Judicial Review

- Unreasonable interpretation of Part 17.2.
- Ministerial Order serves to frustrate the purpose and objects of Part 17.2
- Minister has knowledge of submitted ICF's including Libraries



Conclusion

- December 1, 2022 – “The Minister's decision that library services are third-party services and are not inter-municipal services for the purposes of ICF’s reflects a reasonable interpretation of Part 17.2 of the MGA”
- Judicial review is dismissed



Moving Forward

- Relationship stayed intact
- There was definite net benefit of ICF
- Issue was with Municipal Affairs, not County
- Political Leadership managed things well
- Administration continued to look at areas for cooperation



Emergency Management

- Established Regional Emergency Management Partnership, Agency and Committee with Regional Director
- 2 Towns, 1 County and 2 Villages
- Adopted by Ministerial Order



Fire Services Agreement

- Nearing completion of a joint fire services agreement with 2 Towns, 1 County and 2 Villages, numerous hamlets (+ Waterton park)
- Established
 - Joint Governance Committee
 - Joint Emergency Services Committee
 - Fire Chiefs Committee





Lessons

- Focus on the problem(s), not the person(s)
- Reeve and Mayor played large role
- Administration prepared and stayed neutral
- Concede a battle, to win a war
- Governance, liability, regulatory compliance, and efficiency are rationale for change

Timeline

Decades of discussion

Multiple attempts made at amalgamating the two communities.

July 2017

Completion of the Amalgamation Feasibility Study

September 2021

Both Councils vote to recommend the amalgamation by forwarding the 451-page Amalgamation Report and application to the Minister of Municipal Affairs.

May 2022

Received the Order in Council to approve the formation of the Town of Diamond Valley, Alberta effective January 1, 2023.

March 2012

Both Councils agree to establish a 'Joint Friendship Committee' made up of all members of both Councils

September 2020

Letter of Intent forwarded to Minister of Municipal Affairs. Work began on the actual application.

February 2022

Both newly elected Councils vote to approve the amalgamation at request of Municipal Affairs Minister.

January 1, 2023

It's official – Alberta's newest town, Diamond Valley, is born.


Since the Approval

- Developed an Amalgamation Implementation Plan outlining roles of Council and Staff
- Initiated a Management Transition Team to oversee the process
- Department heads complete worksheets and task listings to determine what needs to be done, when, by who and the resources required to determine budget requirements
- Developed TEAMS site for staff information and FAQ's
- Established a new organizational structure
- Develop new job profiles for all positions
- Selected new Managers and Supervisors
- Prioritized policies and bylaws for Council consideration
- Develop new Human Resource policies
- Align salaries and benefits
- Review staffing and resource requirements

What We Learned

- Collaborative spirit, putting egos aside and trust among Council members is key to success
- Ensure that enough time is allocated from approval to amalgamation to ensure organization success
- Building a strong, positive organizational culture and being responsive to staff related issues is critical to the process
- Engage an excellent Human Resources firm with abundant resources to assist in the process
- Ensure your IT department has sufficient resources since timing will be critical
- You can't over-communicate to staff or the public
- Aligning policies and bylaws ahead of time will save extra work after amalgamation
- It's going to be a lot of extra work for the staff, especially management
- Council is well served by being patient and minimizing all other workloads and projects
- Expect the unexpected despite the best planning and foresight




