10:30 a.m. Provincial Budget Priorities and Advocacy Campaigns

Following a busy summer of engagements, ABmunis is finalizing our pre-budget submission for the Government of Alberta. This session will provide an overview of our priorities in the lead up to the release of the 2026-27 provincial budget. We will also give you the chance to share your thoughts on our upcoming campaigns on reimagining property taxes and strengthening Family and Community Support Services programs and funding.

With the passing of Bill 50, the Municipal Affairs Statutes Amendment Act, in May 2025, there are now new rules for intermunicipal collaboration framework (ICF) agreements. Over the summer, ABmunis, Rural Municipalities of Alberta, and Alberta Municipal Affairs have brainstormed what tools would help municipalities to understand the new legislative rules and work collaboratively with their neighbours. ABmunis will share our ideas to-date and seek your suggestions on what supports you need.
